Sovereign Wealth Funds

Sovereign wealth funds (SWFs) have grown rapidly in recent years in both number and assets. According to the SWF Institute, there are 176 sovereign wealth funds with \$11 trillion dollars of assets under management (AUM) as of 2023, 73 of which were established within the last 12 years. Through their investments, SWFs play a critical role in stimulating economic growth and improving social welfare.

This rapid rise in SWFs—with trillions invested already across the globe—requires a an out-of-the-box approach to identifying and managing risk, protecting and securing investments, and maneuvering cross-border regulatory complexities. Due to rapid growth, many SWFs lack appropriate back-end infrastructure support, resulting in issues with transparency, reporting, and governance which can lead to financial losses and reputational risk.
