#### An International Investigation into Counterfeit Surgical Supplies

K2 Integrity was retained to investigate the supply chain of several surgical products manufactured by an international pharmaceutical company after counterfeit versions were found in U.S. hospitals. As these products are routinely used in surgery, a non-sterile and ineffective counterfeit posed serious health concerns.

Through a combination of open-source research and on-the-ground intelligence gathering, evidentiary test purchases, surveillance, and civil seizures, K2 Integrity worked with the client and outside counsel to trace the path of the counterfeits from the United States through the Middle East and ultimately to India, where the counterfeiter's operation was successfully shut down.

#### An Investigation into Counterfeit Prescription Medication

Working on behalf of a major pharmaceutical company, K2 Integrity was retained to investigate a vast and well-organized network of prescription drug traffickers selling counterfeit prescription medications. The investigation has included the following broad components:

- Open-Source Research: K2 Integrity conducted open-source and public-records-based research into defendants and other individuals of interest.
- Planning and Execution of Federal Civil Seizure Orders: K2 Integrity planned, organized, and executed over 25 civil seizures across seven states, in coordination with law enforcement, outside counsel, and computer forensics technicians.
- Data Review and Analysis: K2 Integrity conducted review and analysis of materials obtained from third parties, including banking data, telephone records, casino records, emails, and mobile communications, among other sources. K2 Integrity also ingested and analyzed hundreds of thousands of banking transactions to support counsel in documenting suspected fraud, identifying new leads, and tracing assets.
